STIPULATED MOTION TO MODIFY
PROCEDURAL SCHEDULE

MOTION

Pursuant to OAR 860-001-0390, Aspen Lakes Estates Owners (“Petitioner”) moves the Public Utility Commission of Oregon (“Commission”) to modify the procedural schedule currently in place in this proceeding as set forth below. Counsel for Petitioner has conferred with counsel for Aspen Lakes Utility, LLC (“Company”) and counsel for Commission Staff, and each supports this motion.

DISCUSSION

On February 26, 2018, Administrative Law Judge Power (“ALJ”) issued a Prehearing Conference Memorandum establishing a procedural schedule in this matter. On April 30, 2018, the ALJ modified the schedule at the request of the parties. The parties continue to engage in discovery in this matter and have determined that it is appropriate to modify the procedural schedule again to allow the initial stages of discovery to conclude prior to the first round of testimony. The parties have also discussed tentative dates for the post-testimony portion of this proceeding, including a preferred date for a hearing. The parties recognize that the actual hearing date will depend on Commission availability. The parties have therefore determined that the procedural schedule should be modified as follows:

- Petitioner Testimony: July 20, 2018
- Respondent/Staff/Intervenor Testimony: August 23, 2018

- All Party Cross-Answering Testimony September 28, 2018
- Cross-Exam Statements: October 4, 2018
- Cross-Exam Exhibits: October 9, 2018
- Hearing: October 16, 2018
- Opening Brief: October 30, 2018
- Closing Brief: November 14, 2018

To accommodate these dates, the parties have also agreed to shorten the timeframe for responding to data requests after July 20th and will use best efforts to provide responses within seven days.

The above dates were generally agreed to by the parties, but the parties agree that specific deadlines may need to be modified in the future as the availability of party representatives becomes more certain.
