3. AWEC is an incorporated, non-profit association of large energy consumers in the Western United States, with offices in Portland, Oregon. A list of AWEC members is included as Attachment A. Many members of AWEC are customers of PacifiCorp, as indicated on Attachment A.

On March 30, 2018, PacifiCorp filed its annual Transition Adjustment Mechanism ("TAM"), the purpose of which is to update PacifiCorp's net power costs and to establish transition credits or charges for direct access customers. Any adjustment to how such costs are passed along to customers will substantially and directly affect those of AWEC's members who purchase power from PacifiCorp as well as those seeking to participate in PacifiCorp's direct access programs. 5. AWEC represents the interests of a number of large customers served by PacifiCorp in Oregon. AWEC also has significant experience participating in proceedings involving PacifiCorp's TAM filings.
