3. Biomass One is limited partnership with offices in White City, Oregon.

Biomass One owns and operates a 25 MW qualifying facility in White City and is a party to a

long term Power Sales Agreement with PacifiCorp. The Power Sales Agreement expires in 2011.

4. Biomass One has a substantial interest in the Commission's investigation to resource sufficiency because of the impact that decision could have on future rate revisions. As a result, the investigation and determination could directly affect Biomass One's future sales of power to PacifiCorp and its business operations.

5. Biomass One's intervention in this proceeding will assist the Commission in resolving the issues in this proceeding and will not unreasonably broaden the issues, burden the record, or unreasonably delay this proceeding.

As described above, Biomass One has a direct and substantial interest in this proceeding that will not be adequately represented by any other party, and may be affected by any Commission determination made in connection with these proceedings. It is in the public interest to allow Biomass One to intervene in this proceeding.


WHEREFORE, Biomass One respectfully requests that the Commission grant its petition to intervene with full party status in this proceeding.


