2. NWIGU is a non-profit association comprised of more than forty end users of natural gas with major facilities in the States of Oregon, Washington, and Idaho. NWIGU members include diverse industrial and commercial interests, including food processing, pulp and paper, wood products, electric generation, aluminum, steel, chemicals, electronics, aerospace and healthcare. The association provides an informational service to its members and participates in various regulatory matters that affect member interests. NWIGU member companies purchase sales and transportation services from Oregon local distribution companies (“LDCs”), including Northwest Natural Gas Company (“NW Natural”).

3. NW Natural initiated this docket in part as a result of Commission Order No. 12-408 entered on October 26, 2012. As part of that order, which the Commission issued in Docket UG 221 addressing NW Natural’s general rate case, the Commission ordered additional proceedings to address unresolved issues relating to interstate gas storage and optimization.

4. NWIGU participated as a party in UG 221. NWIGU’s participation in this proceeding will continue to assist the Commission in resolving the issues, and will not unreasonably broaden the issues, unduly burden the record, or delay the proceeding.

5. NWIGU waives paper service of documents in this proceeding.


