As end user customers of telecommunications services, TRACER members have a direct interest in ensuring (a) that the prices charged by CenturyTel/United for telecommunications services provided to business customers are fair, just, and reasonable; (b) if a price plan should be adopted for the CenturyTel/United companies, whether the prices charged for telecommunications services provided to business customers should be subject to price caps; and (c) if no price caps will apply to business services, what other terms and conditions of the price plan should be included to protect business customers from rate shock or unfair, unjust, and unreasonable price increases.
