c) PGE is a public utility subject to the jurisdiction of the Commission. Decisions made and precedent established in this proceeding may directly affect PGE.

d) PGE is an intervening party in LC 57, PacifiCorp's 2013 Integrated Resource Plan docket. The protective order Sierra Club is alleged to have violated originated in Docket LC 57, and serves as the basis for the creation of this docket. As an electric public utility in the state of Oregon, subject to the Commission's rules and orders regarding confidential materials, PGE has an interest in the issues raised in this proceeding, including any sanctions or further explorations of this issue by the Commission.


e) Moreover, PGE has a direct and substantial interest in upholding the importance of adherence to protective orders, ensuring the integrity of Commission proceedings, and providing parties with the confidence that participation in Commission proceedings does not come at the risk of divulging confidential and proprietary information. Any Commission decision on the issues could affect PGE's business and future dockets.

f) PGE intends to monitor the proceeding and, if necessary, raise issues that are appropriate to the proceeding. No other party could adequately represent the interests of PGE.

Accordingly, PGE's petition to intervene should be granted.


