4. The nature and extent of the Petitioner's interest in the proceeding is:

I am a customer of Lumen who pays for land line service from them. I lodged the complaint in this matter on November 21, 2021, that led the PUC to open this investigation. My complaint should be the first item in the docket. With the exception of individual customers' reports, I have submitted all the filings for our neighborhood, and presented all the comments, in this proceeding in an effort to obtain meaningful relief from the frequent multi-day outages on our Lumen land lines and the lengthy delays caused by Lumen's unyielding reliance on an outage reporting system that does not allow for prompt repairs.

5. The issues the Petitioner intends to raise at the proceeding are:

As far as I know, all the issues we raised are in our complaint and the other submissions and oral proceedings that are already in the file, including our area's particular vulnerability to injury or death because most of us cannot reach emergency help when Lumen's land lines are malfunctioning. It is my understanding that the Citizens' Utility Board will intervene on behalf of the land line customers adversely affected by Lumen's conduct and CUB may have issues to raise in that regard.

6. The special knowledge or expertise of the Petitioner that would assist the Commission in resolving the issues in the proceeding is:

I have been working to obtain the safe and reliable phone service we are entitled to from Lumen and the prior owners of their land line business since 2014.

7. Based on the information provided above in accordance with the Commission's rules of procedure, I request to participate in this proceeding as an intervenor. I or the organization that I represent will not unreasonably broaden the issues, burden the record, or unreasonably delay the proceeding. OAR 860-001-0300.
