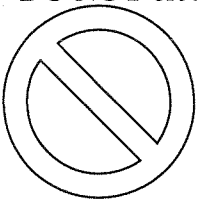

Event Description

On October 25, 2014, a Pacific Coast storm affected electric reliability across the north coast of California and coastal and parts of inland Oregon.¹ This storm, which included the remnants of Hurricane Ana, hammered the area with heavy rain and wind, with gusts up to 45 mph reported. The heavy rain and high and continuous winds caused large trees and limbs to be windborne, breaking and bringing down electrical facilities. Local crews were augmented by outside resources due to the magnitude of the damage. The duration of outages were extended due to cold-load pickup issues (i.e., the immediate demand for power after a prolonged outage results in insufficient capacity, which requires staged restoration by local response personnel, completed by sectionalizing the system into smaller restorations at jumpers and switches). Damage to Pacific Power facilities (overwhelmingly due to wind-blown trees and branches) created power outages throughout the region resulting in a major event through October 27. At the peak of the event, on October 25 at just after 3:00 p.m., the company calculates that 13,963 customers were without service.

¹ During this same time period CoastPlus (which includes Astoria, Portland, Hood River, Lincoln City & Coos Bay) also reached major event threshold levels, however its event CAIDI metric did not reach the 300 minute (6 hour) reporting threshold in 860-023-0161 which requires a major event filing. Metrics are listed below, and details will be provided in the company's 2014 Annual Reliability Report.

CoastPlus SAIDI: 24.40 minutes (threshold 9.57 minutes)

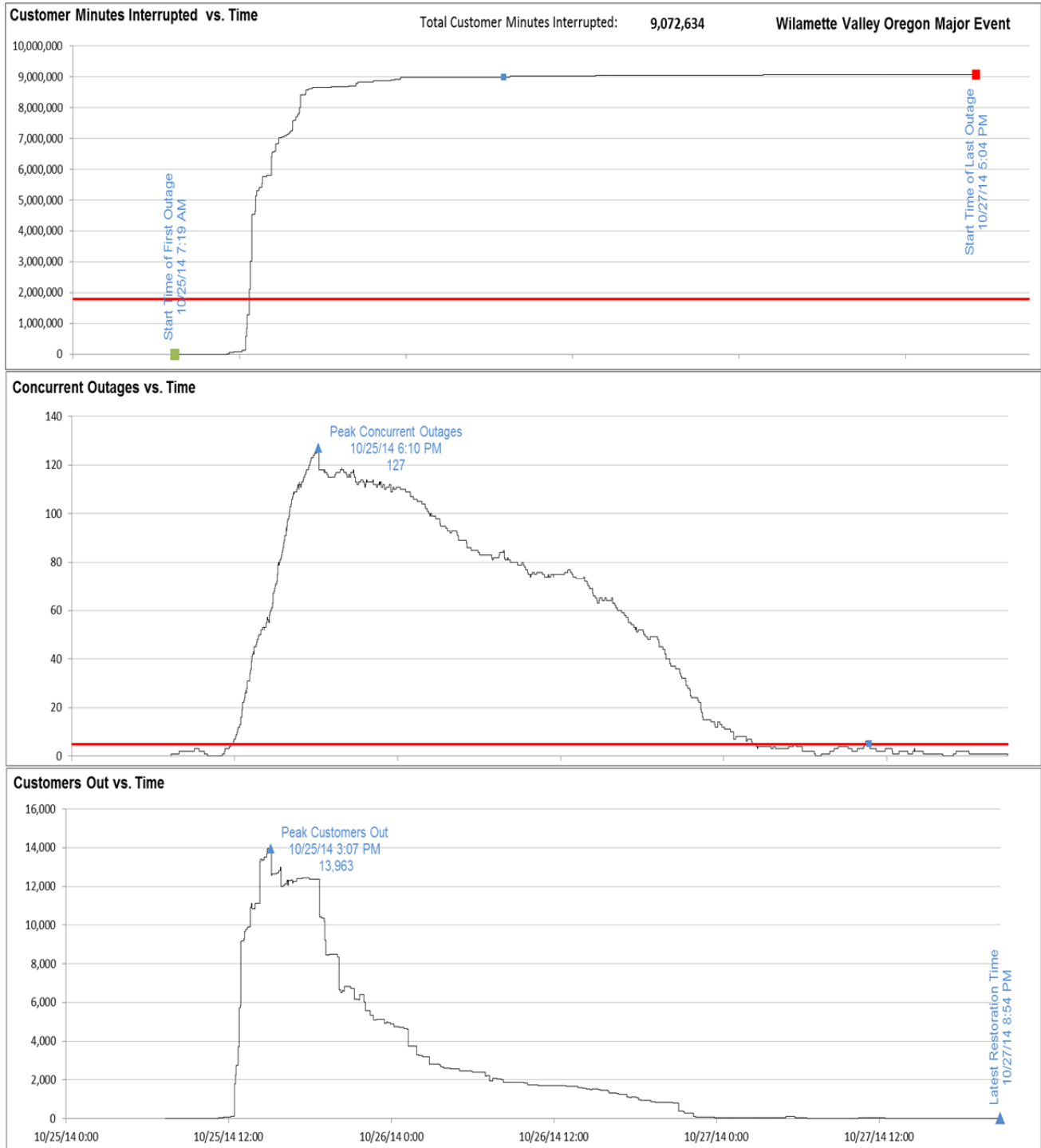

Seventy-two employees and contractors worked to restore service around Sweet Home and Lyons/Mill City. Restoration crews repaired multiple spans of downed wire and replaced numerous transformer fuses and cutouts, many of which were repaired only to be subsequently re-damaged by windborne debris. Some customers experienced multiple outages during the storm, especially in the Cottage Grove/Junction City operating area.

Overall, 24 percent of customers were restored within 3 hours. All power to customers was restored by shortly before 9:00 p.m. on October 27, 2014.
