Pursuant to Order No. 10-414 issued in Docket No. UM 1355, Idaho Power Company (“Company”) is providing information in compliance with Item No. 23 on page 8 of the settlement stipulation approved in the above matter. The stipulation requires the Company to include an annual report on wind resources with its annual Results of Operations Report beginning with the 2010 edition. The report contains the following:

- a. Projected energy by month for the wind resource (megawatt-hours “MWh”)
- b. Projected capacity factor by month for the wind resource (%)
- c. Actual energy by month for the wind resource (MWh)
- d. Actual capacity factor by month for the wind resource (%)
- e. Energy variance by month (MWh) for the wind resource

In addition to the items listed above, the report includes the capacity factor variance by month. The enclosure contains commercially sensitive information detailing actual energy output by project name, and is confidential pursuant to OAR 860-001-0070; therefore, the Company is submitting the confidential information to the Filing Center under separate email with a password protected and encrypted electronic ZIP file in accordance with the filing procedures detailed in the Commission’s Instructions for Stakeholders from the Administrative Hearings Division – New Procedures for Filing.
