DECLARATION


I, Pamela Willmoth, state the following, under penalty of perjury in the State of Oregon:

I am the Senior Director, Property Tax, for Comcast Corporation ("Comcast"). In this capacity, I am familiar with Comcast's qualified project filings with the Oregon Public Utility Commission and its claims for an exemption pursuant to ORS 308.677, and I am authorized to make this declaration.

On June 1, 2018, Comcast and the Oregon Department of Revenue entered into a settlement agreement to resolve multiple lawsuits concerning Comcast's Oregon property tax liability. Pursuant to the settlement agreement, Comcast agreed to withdraw its claims for the gigabit exemption for the 2016-2017 and 2017-2018 tax years, and agreed that it will not claim, and that it is not entitled to, the gigabit exemption, as currently provided for in ORS 308.677, or as modified by the Oregon Legislature, in any future property tax year, beginning with the 2018-19 tax year. Accordingly, Comcast is not claiming to provide the qualified service for purposes of obtaining the ORS 308.677 exemption.

I hereby declare that the above statement is true to the best of my knowledge and belief, and that I understand it is made for use as evidence in court and is subject to penalty for perjury.
