PRIORITYONE TELECOMMUNICATIONS, INC. – ADDITIONAL INFORMATION

<u>PriorityONE owned poles:</u> The only location where PriorityONE owns poles is in Elgin. In January, 2018, PriorityONE and its parent company, Eastern Oregon Net, Inc., acquired the outside plant previously operated by Elgin TV Association. We are still doing an assessment of the poles and outside plant. That assessment should be completed by the end of 2018. Where identified violations have been reported to us, we have corrected those.

Other facilities

PriorityONE operates a limited fiber-optic plant with total construction under five miles. These facilities are in La Grande, Baker City and Enterprise.

In La Grande, with the exception of our original one mile aerial fiber-optic circuit, all fiber-optic facilities are less than two years old. The original one mile circuit in La Grande was inspected within the past year.

In Baker City, there is approximately one mile of underground conduit that was empty since construction until one month ago. These facilities have been inspected in 2018.

In Enterprise there is a one mile aerial fiber-optic circuit built in summer 2014. This circuit is scheduled for inspection during 2018.
