Dear Ms. Bose:

Pursuant to the Federal Energy Regulatory Commission's ("FERC" or "Commission") Final Rule regarding Natural Gas Act Pipeline Maps, B-R Pipeline Company ("B-R") hereby submits revised tariff records to remove the pipeline system map from its tariff and to include a uniform resource locator ("URL") in its tariff to provide access to the map posted on B-R website. The following tariff records are submitted for inclusion in B-R's FERC Gas Tariff, First Revised Volume No. 1:

First Revised Sheet No. 1, 2.0.0. Second Revised Sheet No. 2, 3.0.0. First Revised Sheet No. 3, 2.0.0.

B-R proposes that the revised tariff records submitted herewith be permitted to become effective as of April 24, 2015.

I. Statement of Nature, Reasons and Basis

The purpose of this filing is to comply with Order No. 801's ruling which replaces the requirement that natural gas pipelines include a system map in their tariffs and instead requires pipelines to include in their tariffs "a uniform resource locator on the pipeline's Internet website, at which the general public may display and download system map(s)."²
