Pursuant to Part 154 of the regulations of the Federal Energy Regulatory Commission ("Commission" or "FERC"), Northwest Pipeline LLC ("Northwest") hereby tenders for filing and acceptance the following tariff sheets as part of its FERC Gas Tariff ("Tariff") Fifth Revised Volume No. 1:

Statement of Nature, Reasons and Basis for the Filing

On February 1, 2016, in this docket, Northwest filed to comply with Order No. 587-W¹ by submitting proposed tariff sheets to incorporate Version 3.0 of the North American Energy Standards Board ("NAESB") Wholesale Gas Quadrant's ("WGQ") consensus standards into Northwest's Tariff. On March 29, 2016 ("March Order"),² the Commission accepted Northwest's filing subject to Northwest remedying certain compliance obligations.

Specifically, Northwest was directed to (1) Remove the asterisk from Standard 1.3.15; (2) Remove Standards 2.4.12, 2.4.13, 2.4.14, 2.4.15, and 2.4.16 from the section titled "Standards for which Waiver or Extension of Time to Comply have been granted;" (3) Include the text of Standard 1.3.2(vi); (4) Either incorporate Standards by reference or include the text of the Standards; (5) Remove Standards 2.4.12 through 2.4.16, and 5.3.37 from the section titled "Standards not Incorporated by Reference and their Location in Tariff;" (6) Accurately reflect adoption of Standards

revised by Minor Corrections MC15003, MC15004, MC15005, MC15009 and MC15012 all marked with an asterisk; and (7) Revise the sheet references for Standards 5.3.13, 5.3.14, and 5.3.26 in the section titled "Standards not Incorporated by Reference and their Location in Tariff."

Northwest has made the appropriate Tariff changes to comply with the Commission's directive above with the following clarifications.

Northwest was directed in No. 4 above to either incorporate Standards by reference or include the text of the Standards. In order to comply with this direction and after consulting with Commission Staff to provide more clarity, Northwest proposes to remove General Terms and Conditions ("GT&C") Section 26.3 "Location of Version 3.0 NAESB WGQ Standards in this Tariff," and include the standards that are not incorporated by reference into GT&C Section 26.1 under the heading "Standards not Incorporated by Reference and their Location in the Tariff."

Section 26.3 was added to Northwest's Tariff in its Order No. 587-U³ compliance filing to incorporate into Northwest's Tariff Version 1.9 of the NAESB WGQ consensus standards. As a convenience to Tariff users, Northwest included the table in GT&C Section 26.3 to allow readers a reference to locate NAESB Standards in the Tariff as well as Standards that were included verbatim in the Tariff.⁴ Northwest is now proposing to delete the table and include in GT&C Section 26.1 the standards not incorporated by reference in order to more clearly identify those standards which are not incorporated by reference in the Tariff, and to prevent any confusion that may have been caused by including similar information in both Sections 26.1 and 26.3 of the Tariff.

In addition, in discussions with Commission Staff, directive No. 5 above was intended to include the removal of Standard 5.3.27 and not Standard 5.3.37. Since Northwest has removed Section 26.3, this change is moot. Finally, Northwest has deleted an errant reference to Standard 5.3.27 on Sheet No. 265-D.

Filings Pending Before the Commission

In compliance with 18 CFR § 154.204(f), Northwest states that it has no other tariff filings pending before the Commission that may significantly impact this filing.

Effective Date and Waiver Request

Northwest requests that the proposed tariff sheets filed herein be made effective April 1, 2016, in accordance with Order No. 587-W and the March 29 Order. Northwest requests that the Commission grant any waivers it may deem necessary for the acceptance of this filing.
