Pursuant to Part 154 of the regulations of the Federal Energy Regulatory Commission (“Commission or FERC”), Northwest Pipeline LLC (“Northwest”) hereby tenders for filing and acceptance as part of its FERC Gas Tariff (“Tariff”) Fifth Revised Volume No. 1 the following tariff sheets:

Third Revised Sheet No. 2
Third Revised Sheet No. 4
Third Revised Sheet No. 232-H

Purpose

On November 20, 2014 in Docket No. RM14-21-000, the Commission issued Order No. 801¹ (“Order”) wherein the Commission revised Sections 154.103(a) and 154.106(a) of its regulations in relation to interstate natural gas pipeline maps. By the Order, the Commission eliminated the requirement that pipelines include system maps in their tariffs and the requirement to file updates to those maps by April 30 of any year following a major change. In addition, the Commission retained the requirement for pipelines to maintain a system map on their internet websites and revised the regulations to require pipelines to update the online maps no later than the end of the next calendar quarter after a major system change.

To comply with the Order, Northwest has removed the system map from Sheet No. 4 of its Tariff and has replaced it with a uniform resource locator that will direct the reader to Northwest’s internet website where a copy of the map may be viewed or downloaded. The map posted on Northwest’s website is up-to-date as of December 31, 2014.

In addition, as a result of the change above, Northwest is removing system map related references from Sheet Nos. 2 and 232-H of its Tariff that refer the reader to the map on Tariff Sheet No. 4.

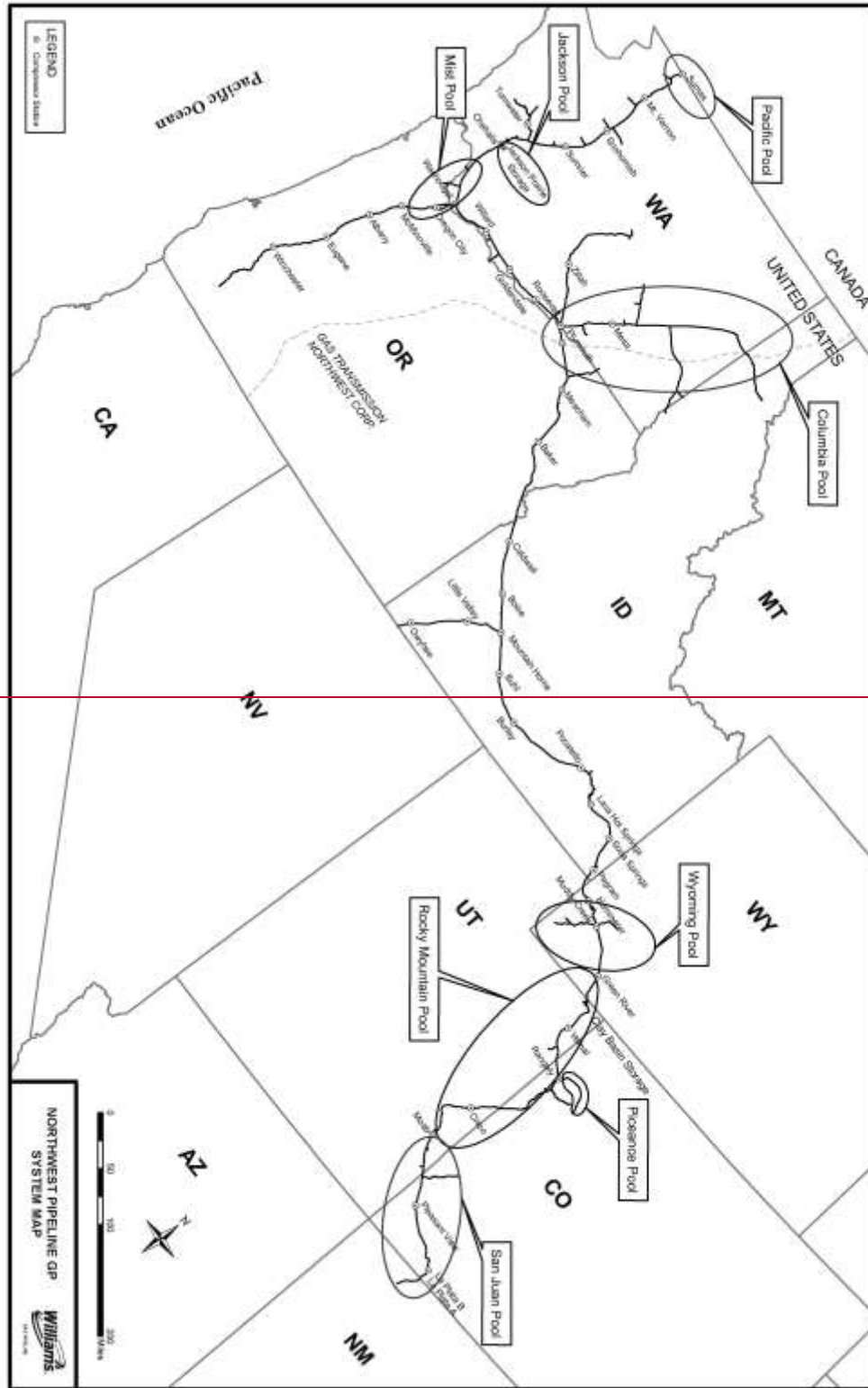
