#### **SECTION 63.71 APPLICATION**

CenturyLink Communications, LLC (FRN: 0018-4219-41),<sup>1</sup> f/k/a Embarq -

Communications, LLC and also f/k/a Qwest Communications Company, LLC d/b/a CenturyLink

QCC, (referred to herein as "CenturyLink") hereby applies for authority to discontinue service to

its remaining customers of various Voice over Internet Protocol ("VoIP") services that have

operated on a VoIP platform, known as Sylantro, that has reached the end of its service life and

is no longer technically supported. Pursuant to Federal Communications Commission

("Commission") authority, these services were grandfathered in 2018.<sup>2</sup> CenturyLink now

platform in all 50 states and Washington D.C.

- Qwest IQ Managed VoIP Bundle: An IP application that provides real-time, two-way voice capability in IP over a broadband connection.

# 6. Dominance of carrier with respect to the service to be discontinued

CenturyLink is a non-dominant carrier with regard to services supported by the Sylantro

VoIP platform.

#### 7. Service

In accordance with 47 C.F.R. § 63.71(a), CenturyLink has mailed a copy of this application to the Governor and public utility commission of each of the affected states and jurisdictions identified in Paragraph 3 above, to any federally-recognized Tribal Nations with authority over the Tribal lands in the geographic areas identified in Paragraph 3 above, as well as to the Special Assistant for Telecommunications under the Secretary of Defense.

If you have not planned with CenturyLink or another telecommunications service provider to replace your voice service listed in Attachment A prior to September 29, 2023, your service will be disconnected, provided that the FCC and state commission, if required, approve the planned VoIP platform discontinuance.
