SECTION 63.71 APPLICATION

Level 3 Telecom<sup>1</sup> hereby applies for authority to discontinue two Voice over Internet Protocol (“VoIP”) services. One of these services, Enterprise IP Trunking, was grandfathered in 2020, pursuant to Federal Communications Commission (“Commission”) authority.<sup>2</sup> Level 3 Telecom now requests Commission authority to discontinue that service, as well as another VoIP service, in all fifty states and the District of Columbia.

Level 3 Telecom submits the following information in support of its application:

**2. Date of planned service discontinuance**

Level 3 Telecom plans to discontinue the Affected Services on September 29, 2023, or as soon thereafter as any necessary regulatory approvals are obtained.

**3. Points of geographic areas of service affected**

Level 3 Telecom seeks authority to discontinue the Affected Services in all 50 states and Washington D.C.

**4. Brief description of the type of services affected**

Level 3 Telecom is seeking to discontinue the following VoIP services:

- Enterprise IP Trunking (or EIPT) is a Voice over Internet Protocol (VoIP) based service which provides PSTN access for TDM and IP telephony customer premises equipment.
- Converged Business Network (or CBN) is a Voice over Internet Protocol (VoIP) based service which provides PSTN access for TDM and IP telephony customer premises equipment bundled with network access.

**5. Brief description of the dates and methods of notice to all affected customers**

Level 3 Telecom sent a written notification of the planned discontinuance to customers affected by the proposed discontinuance in accordance with Section 63.71(a) of the Commission's Rules. Customer notifications were sent by U.S. Mail or United Parcel Service on May 2, 2023. A copy of the notification is attached to this application (Attachment A).

**6. Dominance of carrier with respect to the service to be discontinued**



Level 3 Telecom is a non-dominant carrier with regard to the Affected Services.
