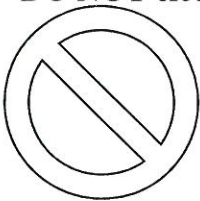



No. 1: Office Lease:

Office Lease dated 12/15/1998, assigned by Lessor Oregon Resorts, LLC (successor by conversion to JELD-WEN Development, Inc) to Eagle Crest Resort Development, LLC. Assignment and Amendment to Lease effective 3/31/2011.

No. 2 – Services Agreement:

Services Agreement between NVHG OR Hotel Operator, LLC and Cline Butte Water, LLC dated August 1, 2012. Services provided are described in Exhibit A to that agreement (copy attached as Attachment B), which exhibit is the template for the annual statement of charges from NVHG OR Hotel Operator, LLC to Cline Butte Water, LLC.

No. 3 – Resort Management Agreement:

Resort Management Agreement by and between NVHG OR Hotel Operator, LLC (as “Operator”) and Oregon Resorts Acquisition Partners, LP (as “Owner”) dated November 19, 2010. Operator provides management of all subsidiary entities held by Owner, which includes Cline Butte Water, LLC. The Base management Fee for such management services is charged at the rate of 3% Adjusted Gross Revenue as defined in the agreement. Each subsidiary entity incurs the 3% base management fee payable to Operator.

No. 4 – Intercompany Line of Credit:

The Agreement described in No. 3 contains the provision for Owner to fund operating and capital expenses of each subsidiary entity managed by Operator. The line of credit balance for Cline Butte Water, LLC at 12/31/2014 was \$252,965.

Chart Titled “Exhibit D-2” depicts the relationship between Oregon Resorts Acquisition Partners, LP and Cline Butte Water, LLC (fka Cline Butte Utilities, LLC). It also shows relationship of affiliated entities Oregon Resorts, LLC and Eagle Crest Resort Development, LLC.

Chart Titled “Exhibit D-3” depicts the relationship of NVHG OR Hotel Operator, LLC as manager “Operator” pursuant to the management agreement with Oregon Resorts Acquisition Partners, LP. An owner of NVHG OR Hotel Operator, LLC is Member of Running Y Water, LLC, Oregon Resorts, LLC and Eagle Crest Resort Development, LLC as well as an indirect minority owner in Oregon Resorts Acquisition Partners, LP.



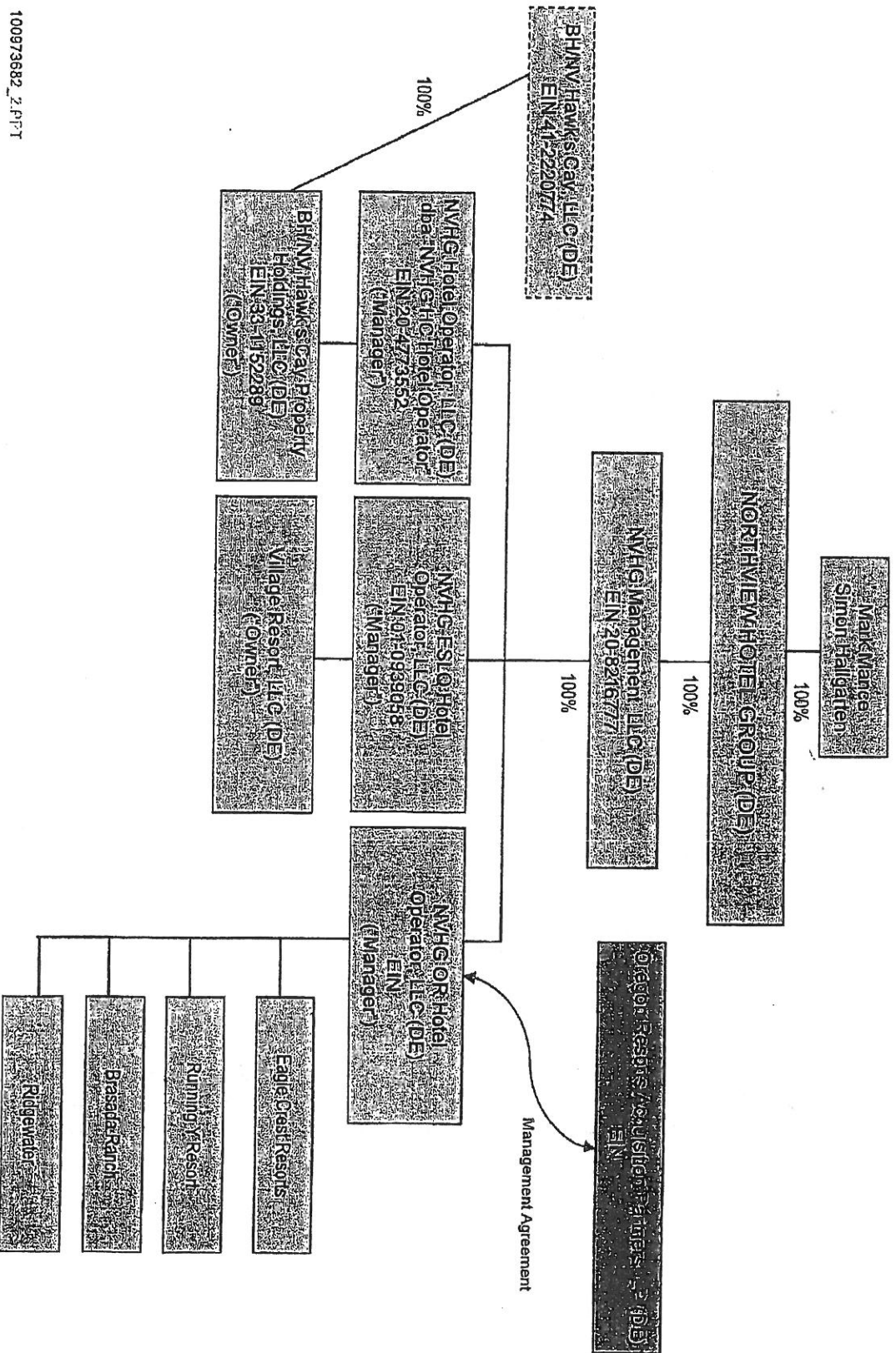








# EXHIBIT D-3 Management Org Chart
