Attached is a group of extension request we hope to have granted by the PUC. There are 13 requests in total, but they are all a result of the same issue.

Although there are 13 request there is only 4 customers associated with these projects. 3 of the 4 customers are located on Sauvie Island. In August of 2014 we requested extension request for these projects due to technical difficulties associated with the Geo Tec reports we obtained from the sites.

We had estimated being able to finish securing the financing to build these project by January 2015. That process has taken longer than anticipated, but we have finally reached the final stages. Our financing is now secure, but is contingent upon receiving another extension. Once the extension is approved we will have a very short 2 week closing cycle and then will be able to focus on getting the projects built.

To date we have invested approximately \$65,000.00 in these projects in terms of Interconnection, Engineering and design, Geotec reporting, permit submittals, and completing the necessary steps to ensure the proper and safe execution of these projects.

We are attaching a letter from our financing entity to demonstrate their commitment to the projects.

Wiser Capital anticipates commencing construction prior to the expiration date of the existing Reservation. A 3 month extension was previously granted due to "good cause" related to the discovery of additional soil/geological testing and engineering work that was required. The PUC recognized that a "cascade of events" thus delayed the project, including the finalizing of financing. Now, with financing finalized, and the cascade of events resulting from the previously mentioned "good cause" for delay fully addressed, Wiser Capital requests an additional extension, or other accommodation or assurance, to provide clarity that upon its commissioning, if within a reasonable time after the



expiration of the current Reservation, and according to other conditions that may be set by the PUC, the project may move forward with its current economics preserved.

If an additional extension or accommodation is granted Wiser Capital anticipates beginning construction within four-eight weeks of such extension or accommodation (ideally prior to the expiration of the existing Reservation) and expects completion 30-60 days thereafter, with Commercial Operation set to begin no later than June 30 2015.

We request this extension so as to ensure the now nearly finalized financing has the certainty that their investment may be completed once construction has begun.
