Request for waiver of OAR 860-084 Installation Requirement

Commissioner,

Dynamic Power Innovation is submitting this request on behalf of our Customer, Bethany Development, LLC. which received two 9.0 Portland General Electric Solar Payment Program Reservation (Y8V2R4 and R068J0) with an installation deadline of April 14, 2015. Dynamic Power is requesting a 6 month extension from April 14, 2015 to October 14, 2015 to the OAR 860-084-2010 (1) Installation requirements in order to allow time for the system completion.

The two 9.0 VIR Solar incentives were awarded on April 14, 2014. Bethany Development had started development on the assisted living complex at West Parc at Bethany Village, Portland, Oregon. Jeff Oberst, construction manager at Central Bethany Development, had anticipated completion of the assisted living project by January 2015. Engineering had been completed and the required permits were applied for. Due to a reduction in the Permitting Center staff, the review and approval of the permits took 6 months' time. When Bethany Development finally got the approved permits, the framing company they had hired for the West Parc Development had started another construction project. Bethany Village, having a long standing history with this framing company, decided to delay the Bethany project until their preferred framing company was available to man the site. The unexpected extended permitting delay delayed the progress of the installation of the solar array. All necessary funding for the project is secured and construction is currently proceeding on schedule. Bethany Development along with DPI is confident a 6 month extension gives us adequate time to complete the solar portion of the

project. DPI and West Parc Development are reasonably confident that the project will be completed in August, however since this is a new construction project, unexpected delays can happen and we would rather ask for additional time up front to cover any unforeseen circumstances.

Dynamic Power Innovation had previously acquired and paid for the required engineering, submitted all interconnection agreements and PGE Contracts, are in the process of applying for solar Building permits and Electrical permits with the City of Portland. DPI has secured the solar panels, inverters and racking.

Mr. Oberst would like to preserve these two incentives. The concept of adding solar to subsidize electrical cost to an assisted living building is one Bethany Development wants to continue to pursue. He feels the benefit of solar to diminish electrical costs will be attractive to the fixed income cliental. These two initial projects are the first of six housing developments that will follow the same solar footprint .

We hope that the circumstances along with Dynamic Power Innovations previous history of installing Photovoltaic Systems under this program in a timely fashion will help the commission rule in our favor. Please let me know if you require additional supporting documentation that would benefit us towards a favorable decision.
