This filing is in regards to a SolarCity Solar Payment Option project, <u>D7K0S9</u>, located in Oregon. This project was dropped from the Solar Payment Option program because the utility did not receive an interconnection application by the two month deadline. The two month deadline for this project was on March 13, 2016 SolarCity is asking that the rule of submitting Interconnection documents by the two month deadline be waived for this project. This would allow the project to stay in the Solar Payment Option program. SolarCity did not engage with the utility in any way on behalf of the customer before the submission for interconnection on March 13, 2016. Since the notification of the missed deadline was made, SolarCity has reached out to the Oregon Public Utility Commission to get this project back into the Solar Payment Option program. SolarCity started reaching out to the Oregon Public Utility Commission as soon as we became aware that an official waiver would need to be requested in order to keep the project in the Solar Payment Option program.

The confidential materials being sent by mail include the capacity reservation letter. If this project receives its waiver, it will be completed and connected to the grid by August 2016. This fully funded project has already been installed and is ready to receive Permission to Operate. The host customer is very eager to join other Oregon citizens in using renewable energy.
