PGE filed the application requesting a partial waiver on April 1, 2020. The Commission granted the partial waiver effective May 20, 2020 for a period of 60 days pursuant to Order No. 20-170. On July 15, 2020, the Commission extended PGE's temporary partial waiver of OAR 860-021-0130(2) for a period of 6 months effective July 15, 2020, pursuant to Order No. 20-225. On January 11, 2021, PGE requested an extension of the temporary partial waiver for an additional 6 months. The Commission granted the extension which is set to expire on July 15, 2021.

PGE now requests that the Commission grant this petition extending Order No. 21-028 to December 31, 2021 due to the continuing COVID-19 public health emergency, evolving OSHA guidelines and ongoing vaccination efforts.

PETITION TO EXTEND PARTIAL WAIVER OF METER TEST (EXPEDITED CONSIDERATION REQUESTED)

Pursuant to OAR 860-001-0390(2)(B) and 860-001-0700, Portland General Electric Company (PGE) hereby submits to the Commission this petition requesting an extension of the partial waiver of the requirements of OAR 860-021-0130(2) Meter Test relating to a customer's right to be present at any meter test. PGE filed the application requesting a partial waiver on April 1, 2020. The Commission granted the partial waiver effective May 20, 2020 for a period of 60 days pursuant to Order No. 20-170.

PGE then requested that the Commission amend Order No. 20-170 extending the temporary partial waiver of OAR 860-021-0130(2) an additional 90 days due to the continuing COVID-19 public health emergency. On July 15, 2020, the Commission extended PGE's temporary partial waiver of OAR 860-021-0130(2) for a period of 6 months effective July 15, 2020, pursuant to Order No. 20-225.

On January 11, 2021, PGE requested an extension of the temporary partial waiver of OAR 860-021-0130(2), for an additional 6 months, that was set to expire on January 15, 2021. The Commission granted the extension pursuant to Order No. 21-028 which is now set to expire on July 15, 2021.

Due to the continuing COVID-19 public health emergency, evolving OSHA guidelines and ongoing vaccination efforts, the Company requests that the Commission grant this petition extending Order No. 21-028 to December 31, 2021.
