
**AMENDMENT MODIFYING THE PROPOSED DESIGNATED SERVICE AREA
TO EXCLUDE THE WARM SPRINGS INDIAN RESERVATION**

Boomerang Wireless, LLC d/b/a enTouch Wireless (“Boomerang” or the “Company”) respectfully submits this Amendment to its pending Application for Limited Designation as an Eligible Telecommunications Carrier (“ETC”) and Eligible Telecommunications Provider (“ETP”), which was filed in this docket on August 2, 2013 (the “Application”). The sole purpose of this Amendment is to modify the area in which designation (defined in the Application as the “Designated Service Area”) by specifying that the proposed Designated Service Area does not include any portion of the Warm Springs Indian Reservation. To the extent that Boomerang seeks ETC or ETP designation in any wire center or ZIP code overlapping any portion of the Warm Springs Indian Reservation, Boomerang clarifies that it seeks designation only in the portion of each such wire center or ZIP code that does not overlap the Warm Springs Indian Reservation. Following consultations with the Oregon Public Utility Commission staff and other parties, Boomerang expects to further refine the Designated Service Area in a stipulation or a later amendment, but such a stipulation or amendment will not alter the exclusion of the Warm Springs Indian Reservation from the Designated Service Area. If, someday in the future,

Boomerang seeks designation on any portion of the Warm Springs Indian Reservation, it will file a supplemental application seeking such designation that would allow any person with an interest in such designation to intervene pursuant to the rules of the Oregon Public Utility Commission.
