**SUBJECT:** Stayton Cooperative Telephone Company, Supplemental Filing to Advice No. 3/ADV 49, Revises 800 Data Base Access Service Query for parity with NECA's rates filed with the FCC on June 16, 2015, to become effective July 1, 2015.

I have reviewed this filing and recommend that an acknowledgement letter be sent. The filing was submitted on June 17, 2015, and will go into effect on July 1, 2015.

This filing revises Stayton Cooperative Telephone Company's Tariff PUC Or. No. 4, Access Services, as required by FCC Order No. 11-161, released November 18, 2011, further orders in FCC WC Docket No. 10-90, FCC Order No. DA 15-368, adopted March 27, 2015, and FCC Order No. DA 15-458, adopted April 14, 2015. 800 Data Base Access Service Quality rates are being revised to be at parity with NECA's rates filed with the FCC on June 16, 2015.
