MEMORANDUM

This docket has been opened for the Commission's review of whether Sierra Club violated Protective Order No. 13-095, which was issued to govern the access and review of information designated as confidential in docket LC 57, PacifiCorp's 2013 Integrated Resource Plan. This docket is a contested case proceeding as defined in ORS 183.310(2)(a). Counsel for Sierra Club, who is not a member of the Oregon bar, should review OAR 860-001-0320 and rules of the Oregon State Bar to determine whether a motion to appear *pro hac vice* is necessary.

The following filings previously submitted in this matter will be docketed in UM 1707:



- Chief ALJ Grant's August 27, 2014 email to Sierra Club and PacifiCorp denying Sierra Club's motion for concurrent schedules and adopting filing dates

The Commission will also include in docket UM 1707 the audio recordings from the telephone conferences held on August 18 and 27, 2014. The Commission will not post any filings containing confidential information on the agency's website.

Parties should use docket designation UM 1707 for future filings related to the claimed breach of Protective Order No. 13-095. If necessary, the parties may request that the Commission take official notice of documents filed in docket LC 57.

Sierra Club's August 22, 2014 Motion Challenging Confidential Designation will be docketed in LC 57. Parties should use docket LC 57 for future filings related to challenges to the designation of confidential information in that docket.
