**DISPOSITION: PROCEDURAL SCHEDULES AMENDED**

On September 7, 2012, the Commission held a telephone prehearing conference in dockets UE 246, UE 245, and UE 233. Representatives appeared on behalf of the Commission Staff; PacifiCorp, dba Pacific Power; Idaho Power Company; the Citizens' Utility Board of Oregon; the Industrial Customers of Northwest Utilities; Sierra Club; Noble Americas Energy Solutions; and the Oregon Industrial Customers of Idaho Power.

**UE 246 and UE 233**

These dockets are proceeding on the same schedule. I advised the parties that prehearing briefs for both dockets should thoroughly discuss all issues relevant to each party.

Parties in both dockets should be prepared to move forward with cross-examination on October 2. The hearing in UE 246 will begin at 8:30 a.m. I anticipate completing the hearing in UE 246 on October 2 and moving immediately on to the hearing in UE 233 on the same day, leaving October 3 for additional time if necessary to complete cross-examination in UE 233.

With regard to exhibits, parties should file with the Commission one original and four paper copies of all exhibits except exhibits consisting of previously published Commission orders. Parties may file with the Commission one paper copy of previously published Commission orders, and may serve other parties with a list of Orders and links to the online Orders.

At the conference, I adopted the following amended dates for UE 233 and UE 246:

All Parties file Exhibits and Cross-Examination Statements	September 27, 2012, Noon
All Parties Objections due	September 28, 2012
Hearings	October 2-3, 2012 <sup>1</sup>


