## Mr. Brooks:

There will be no "non-party" evidence. Were a "non-party" to appear and ask to intervene, that request will be granted, subject to the standard limits on intervention — interest in the proceeding, no broadening of the issues. Any testimony that would be proffered would have to be relevant.
