This rulemaking proposes to update the adopted American National Standard for Tree Care Operations, ANSI A300 (Part 1) from the 2001 edition to the 2008 edition, approved May 1, 2008 by the American National Standards Institute.

Need for the Rule(s):

The update to the rule is necessary to adopt the current national standard.

American National Standard for Tree Care Operations, ANSI A300 (Part 1) 2008 (copyrighted material) is available for purchase from Tree Care Industry Association at http://tcia.org/business/ansi-a300-standards/part-1 and is available for review at the PUC at 3930 Fairview Industrial Drive SE, Salem, Oregon.

Fiscal and Economic Impact:

The adoption of the current national standard for pruning is not anticipated to create additional costs or savings to the subject utilities. The differences between the 2001 edition and the 2008 edition have minimal impact on the Oregon utilities subject to the standard. Adopting the more recent edition may help to ensure consistency for those electric utilities with multi-state operations.

Statement of Cost of Compliance:

1. Impact on state agencies, units of local government and the public (ORS 183.335(2)(b)(E)):

Because the more recent edition of the national standard does not contain major significant changes from the previous edition, especially with regard to vegetation native to Oregon, it is anticipated that the costs to comply with the more recent edition of the standard will be similar to the costs of compliance to the 2001 edition. Only electric utilities, as defined in ORS 758.505, are subject to the rule. The PUC incurred the cost of purchasing the more recent edition of the standard.

2. Cost of compliance effect on small business (ORS 183.336):

a. Estimate the number of small business and types of businesses and industries with small businesses subject to the rule: Electric utilities, as defined in ORS 758.505, are subject to the rule. None of these entities meet the statutory definition of a small business.

b. Projected reporting, recordkeeping and other administrative activities required for compliance, including costs of professional services:

The adoption of the more recent edition of the national standard is not anticipated to change the current reporting, recordkeeping or other administrative activities required for compliance.

c. Equipment, supplies, labor and increased administration required for compliance:

The adoption of the more recent edition of the national standard is not anticipated to change the current equipment, supplies, labor, or administration for compliance.

Small businesses were not involved. The change updates the rule to adopt the current national standards.
