Notice of Withdrawal of Form No. 556 for the Qualifying Facilities Listed on Attachment A

Dear Secretary Bose:

Pursuant to section 292.207(a) of the regulations of the Federal Energy Regulatory Commission (Commission), each of the companies listed in Attachment A to this notice previously filed a Form No. 556 certifying a solar-powered generating facility as a qualifying small power production facility (QF) under the Public Utility Regulatory Policies Act of 1978, as amended (collectively, the QF Self-Certifications). The QF Self-Certifications were filed by the original developer of the facilities (collectively, the Projects), which has since sold its interests in the Projects to an affiliate of Longroad Energy Holdings, LLC (LEH).

Upon further review of the Projects, LEH has confirmed that each Project has a net power production capacity of 1 MW or less and therefore is exempt from the requirement to file a Form No. 556 to obtain QF status pursuant to section 292.203(d) of the Commission's regulations. Because the QF Self-Certifications are not required and are out of date with respect to ownership and certain administrative information, LEH hereby notifies the Commission that it withdraws the QF Self-Certifications on file in the dockets referenced in Attachment A. Notwithstanding such withdrawal, each Project continues to be a QF in accordance with Part 292 of the Commission's regulations.
