RE: Notice of Ex Parte Communication

The purpose of this letter is to notify all parties to docket UG 266 of an *ex parte* communication that occurred in an e-mail sent by Commissioner Bloom to some, but not all, parties.

On November 19, 2013, Commissioner Bloom sent an e-mail to Lisa Rackner, counsel for Northwest Natural Gas Company, to point out errors in transcript attached to testimony of Barbara Summers submitted by the company on November 18, 2013. Commissioner Bloom, who copied the e-mail to certain Commission employees and parties, noted that some of the statements transcribed from the October 28, 2013 Public Meeting were attributed incorrectly. A copy of Commissioner Bloom's e-mail, as well as Chief Administrative Law Judge Michael Grant's reply to all recipients, is attached.

OAR 860-001-0340(2) sets forth the circumstances that constitute an *ex parte* communication. OAR 860-001-0340(5) sets forth the duties of the presiding ALJ in the event an *ex parte* communication occurs.

The e-mail meets the definition of *ex parte* communication under OAR 860-001-0340(2) and must be disclosed. Copies of the comments will be placed in the record. Pursuant to OAR 860-001-340(7), any party may file a written rebuttal to the *ex parte* communication, within 10 days, with service to other parties to the proceeding.

Good afternoon, Lisa.

I just finished reading Mark and Barbara's Testimony in the above-referenced matter.

I write to point out what I believe to be a couple of errors in the transcript of the public meeting that were attached to Barbara's testimony:

- 1. I believe the statements on page 8 and 9 attributed to Erik Colville are really the statements of Mr. Campbell from Clean Energy.
 - a. Campbell is talking on page 7 and 8, responding to questions from Susan, and then the court reporter shifts to "Colville".
 - b. See also page 9, line 3, where allegedly Colville "would like to have the tariff disapproved" etc.
 - c. Which I believe is inconsistent with Erik's staff report (see page 5, line 15-16).
- 2. I believe the comments attributed to me on page 28, beginning at line 10, are really Bob Jenk's.
 - a. See Susan's comments to "Bob" on line 23, page 28.
 - b. And, I know that Bob drives an "alternative -fueled vehicle" (see line 17, page 28); no one would ever confuse my 16 year old car as "alternative-fueled"...:-).
