ASSURANCE WIRELESS USA, L.P.'S NOTICE OF RELINQUISHMENT OF ITS ELIGIBLE TELECOMMUNICATIONS CARRIER AND ELIGIBLE TELECOMMUNICATIONS PROVIDER DESIGNATIONS **PURSUANT TO 47 U.S.C. §214(e)(4)**

Pursuant to 47 U.S.C. §214(e)(4) and 47 C.F.R. § 54.205(a), Assurance Wireless USA, L.P. dba Assurance Wireless (hereinafter, "Assurance" or the "Company") hereby submits this Notice of Relinquishment of its Eligible Telecommunications Carrier ("ETC") and its Eligible Telecommunications Provider ("ETP") designations in the State of Oregon, effective as of March 1, 2022. As explained herein, this relinquishment of Assurance's ETC and ETP designations meets all applicable requirements and should be expeditiously granted.

II. **BACKGROUND**

On January 23, 2012, the Commission issued Order No. 12-015 in docket UM 1522, in which it designated the Company as an ETC and an ETP to enable Assurance to offer prepaid wireless services supported by the federal USF Lifeline Program and to participate in the Commission's Oregon Telephone Assistance Program ("OTAP"). Consistent with the request in the Company's application, the Commission excluded any Tribal Lands that lie within the

geographic boundaries of the wire centers used to define Company's designated ETC/ETP area. On November 8, 2017, the Commission issued Order No. 17-454 in docket UM 1522, in which it approved the use of zip codes, rather than incumbent local exchange carrier ("ILEC") wire center boundaries, to define Assurance's ETC and ETP designated service area.

III. ASSURANCE'S NOTICE OF RELINQUISHMENT OF ITS ELIGIBLE TELECOMMUNICATIONS CARRIER DESIGNATION

On April 1, 2020, Sprint and T-Mobile USA, Inc. ("T-Mobile") completed their merger. Assurance Wireless is now an indirect subsidiary of T-Mobile. T-Mobile is at the forefront in providing innovative and superior service offerings to its customers and giving back to the community. In particular, T-Mobile offers a variety of low-cost service plans to various consumers in Oregon, including T-Mobile Connect and Project 10 Million. The T-Mobile Connect plans include (1) unlimited voice and text and 2.5 GB of data for \$15.00 per month, or (2) unlimited voice and text and 5.5 GB of data for \$25.00.² Project 10 Million represents a \$10.7 billion investment over five years that offers individual students and school districts free Internet access of 100 GB of data per year and mobile hotspots for 10 million eligible households.³

Assurance Wireless and other T-Mobile brands also participate in the FCC's temporary Emergency Broadband Benefit (EBB) program which provides eligible customers with up to \$50.00 in support towards broadband services.

Due to T-Mobile's focus on these and other initiatives, Assurance has decided that it will not continue to operate as a Lifeline-only ETC in Oregon. Assurance, therefore, provides this

Notice of its intent to relinquish its ETC and ETP designations in Oregon, effective April 1, 2022. Assurance Wireless will stop seeking federal Lifeline support after December 31, 2021.⁴

A. Assurance's Relinquishment of ETC Designation Complies with Federal Law

The Commission "shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier." 47 U.S.C. section 214(e)(4) states in relevant part:

(4) Relinquishment of universal service

A State commission (or the Commission in the case of a common carrier designated under paragraph (6)) shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier. An eligible telecommunications carrier that seeks to relinquish its eligible telecommunications carrier designation for an area served by more than one eligible telecommunications carrier shall give advance notice to the State commission (or the Commission in the case of a common carrier designated under paragraph (6)) of such relinquishment. Prior to permitting a telecommunications carrier designated as an eligible telecommunications carrier to cease providing universal service in an area served by more than one eligible telecommunications carrier, the State commission (or the Commission in the case of a common carrier designated under paragraph (6)) shall require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier. The State commission (or the Commission in the case of a common carrier designated under paragraph (6)) shall establish a time, not to exceed one year after the State commission (or the Commission in the case of a common carrier designated under paragraph (6)) approves such relinquishment under this paragraph, within which such purchase or construction shall be completed.

In summary, the statutory requirements for relinquishing ETC designation are: (1) there must be more than one ETC serving in the area of the ETC seeking relinquishment; (2) the ETC seeking relinquishment must provide advance notice to the relevant state commission; (3) the customers served by the relinquishing ETC must continue to be served by an ETC; and (4) to the extent that additional facilities are required to serve any of the relinquishing ETC's customers, sufficient notice shall be provided to ensure that the construction or purchase can be timely completed. The relevant FCC rule essentially reiterates the same requirements.⁶

Assurance's application for relinquishment of its ETC designation in Oregon complies with federal law⁷ and must be granted because: (1) there is currently more than one ETC serving the ETC Service Area; (2) Assurance is providing advance notice to the Commission of such relinquishment; (3) the remaining ETCs in the market are able to serve the Lifeline needs of consumers within their respective designated ETC service areas that cover the ETC Service Area; and (4) no additional facilities will need to be purchased or constructed by the remaining ETCs.

1. There Is More Than One ETC Currently Serving Each Wire Center in the ETC Service Area

Assurance's ETC Service Area is currently served by more than one ETC.⁸ Because at least one other ETC serves in Assurance's ETC Service Area, applicable federal law requires the Commission to permit Assurance to relinquish its ETC designation.

2. Assurance Is Providing Advance Notice to the Commission

Consistent with 47 U.S.C. §214(e)(4) and 47 C.F.R. § 54.205(a), Assurance is filing this Notice over four months in advance of the requested effective date of relinquishment of its ETC designation. This advance notice satisfies the requirement to provide advance notice to the Commission of the Company's intent to relinquish its ETC designation.

3. The Remaining ETCs Will Serve Consumers

To the best of Assurance's knowledge, the ILEC ETCs and CETCs in the ETC Service Area will continue to serve customers in the ETC Service Area. Thus, all customers within the Company's ETC Service Area will continue to be served by an ETC, consistent with 47 U.S.C. § 214(e).

Assurance has approximately 27,000 Lifeline customers in Oregon. Assurance will stop accepting new applications for Lifeline service on December 31, 2021. Assurance will provide notice to its Assurance Lifeline customers that it will no longer participate in the Lifeline program. Customer notification will take place in three stages. First, at least sixty (60) days prior to relinquishment, Assurance will send a text message to customers. Second, Assurance will send a letter via U.S. mail to subscribers at least forty-five (45) days before relinquishment. Third, Assurance will send follow-up text messages thirty (30) days and fifteen (15) days prior to relinquishment to remaining customers. The notice will inform these customers that they will receive courtesy credits in the amount of their Lifeline discount for 45 days. This notice process will afford Assurance's Lifeline customers time to select an alternative to Assurance's Lifeline calling plan, including EBB service from Assurance, a T-Mobile calling plan such as T-Mobile Connect, or they may obtain discounted Lifeline service from another ETC.

4. No Additional Facilities Will Need to Be Purchased or Constructed by the Remaining Eligible Telecommunications Carriers

Area. Because the remaining ETCs currently serve the entire area in which the Company is

designated as an ETC in Oregon, the Commission need not provide notice to these carriers to

permit them to purchase or construct facilities to ensure that Assurance's customers will continue

to receive service.

Through this Notice, Assurance has complied with all requirements of 47 U.S.C.

§214(e)(4) and 47 C.F.R. § 54.205. There is no barrier to prevent the Company from

relinquishing its ETC designation in Oregon. Therefore, the Commission should issue an Order

acknowledging Assurance's notice of relinquishment.

IV. CONCLUSION

Consistent with all applicable requirements, Assurance respectfully requests the

Commission expeditiously issue an Order acknowledging its notice of relinquishment of its ETC

and ETP designations in Oregon. Assurance has demonstrated that it meets the requirements for

relinquishment of its ETC designation.
