**PACIFICORP’S NOTICE OF
VOLUNTARY WITHDRAWAL**

PacifiCorp respectfully submits this notice of voluntary withdrawal of its petition requesting an expedited waiver of certain requirements Oregon Administrative Rule (OAR) 860-038-0300 (Petition) as it relates to its annual fuel mix disclosures. In its Petition filed on October 19, 2023, PacifiCorp requested a waiver of OAR 860-038-0300(6) that requires PacifiCorp’s annual fuel mix disclosures to include the most recent unspecified market purchase mix as determined by the Oregon Department of Energy (ODOE). Since ODOE had not yet provided PacifiCorp with its unspecified market purchase mix estimate for 2021 generation, PacifiCorp requested the Oregon Public Utility Commission (Commission) to grant the waiver and allow the Company to use the unspecified market purchase mix that was included in the previous year’s fuel mix report.

On October 24, 2023, PacifiCorp and Commission Staff discussed the Company’s Petition and Staff indicated the rule language allows the Company to use the currently available data from ODOE in its annual fuel mix disclosure, even though the data is not from the same year as the reported specified fuel mix data. Based on its discussions with Staff, Company voluntarily withdraws its Petition and will use the calendar year 2020 as the

currently available unspecified market purchase mix ratio and emissions impact analysis from ODOE for its 2021 annual fuel mix disclosure mailing in 2023.
