2. I sponsored pre-filed Rebuttal Testimony on behalf of PacifiCorp in the
above-referenced docket.

3. My pre-filed Rebuttal Testimony (PPL/1603) is true and accurate, with the
following exception:

- I inadvertently omitted the words "for purposes of Oregon ratemaking" from the statement on page 3, lines 2 through 5 of my Rebuttal Testimony. That statement should read: As shown in Appendix H, Page 7 of 9, of the Commission's Order (05-1050) in this Docket, the Oregon imputed revenues are \$7,010,000 (column P-5, line 4) and \$1,330,000 is being allocated for purposes of Oregon ratemaking to States other than Oregon (column P-6, line 5).

4. With the exception noted above, if I were asked the same questions today, my
answers would be the same.

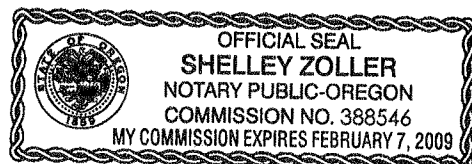
