Has the Company ever considered the existence of a long-term take-or-pay contract as part of any economic analyses related to the installation of selective catalytic reduction (SCR) controls for the Hayden generating station? If so, how did the existence of a long-term take-or-pay contract influence the results of such an economic analysis?

Confidential 1st Revised Response to Sierra Club Data Request 1.31

This response replaces, in its entirety, the Company's original response dated January 28, 2015.

The Company objects to this request as not reasonably calculated to lead to discovery of admissible evidence. Without waiving this objection, the Company responds as follows:

Yes. If take-or-pay provisions were applicable under an early retirement scenario, the present value of revenue requirements differential (PVRR(d)) comparing selective catalytic reduction (SCR) versus early retirement was reduced by approximately with the

reduction being less favorable to the SCR alternative. While the economic impact of coal contract take-or-pay provisions was reported in the Company's economic analysis, this analysis did not influence Company decisions regarding the SCR project at Hayden Unit 1.
