2	Q.	Please state your name and title.
3	Α.	Justin Palfreyman, Vice President of Strategy and Business Development for NW
4		Natural Gas Company (NW Natural or Company).
5	Q.	Please summarize your professional experience and educational
6		background.
7	Α.	I have worked for 15 years in strategy, finance and corporate development
8		functions. I most recently worked as a Director in Lazard's Power, Energy and
9		Infrastructure Group in New York, where I provided strategic and financial advice
10		to corporations, institutional investors, private equity funds and government
11		clients. My advisory assignments related to general strategic advice; mergers,
12		acquisitions and divestitures; raising capital; restructurings; corporate
13		preparedness/takeover defense; and capital structure optimization. Prior to
14		Lazard, I worked in the Infrastructure Investment Banking Group at Goldman
15		Sachs in New York. I also previously held various positions in finance, strategy
16		and business development at both Apex Learning and Accenture in Seattle,
17		Washington.
18		I hold an MBA from The University of Chicago Booth School of Business,
19		a Master's of Public Policy from The University of Chicago Irving B. Harris School

25		protections of the modified protective order, highly confidential, competitively


1	sensitive details regarding the Company's strategic plan for growth, which was












