Notice of Promotional Activity

Northwest Natural Gas Company, dba NW Natural ("NW Natural" or "Company"), files herewith the following revisions to its Tariff P.U.C. Or. 25, stated to become effective on and after October 1, 2014:

> First Revision of Sheet 200-3, Schedule 200. "Promotional Concessions."

The first purpose of this filing is to propose changes to the Company's Tariff Schedule 200, Sheet 200-3 Equipment Sales Promotions, to add builders and developers to the available section of the Schedule.

The second purpose of this filing is to provide notice, in accordance with OAR 860-026-0030, of a promotional activity directed at builders and developers of multi-family buildings. The details of the promotional activity are described below:

The Company will offer to qualifying builders or developers of residential multi-family buildings with a minimum of four units, an amount per unit for the installation of gas-fired appliances as follows:

Up to \$500 for space $^{[1]}$ and water heating equipment; Up to \$400 for space heating $^{[1]}$ or water heating and gas cooking; Up to \$350 for space heating $^{[1]}$ or water heating;

Up to \$150 for gas cooktop, oven, and gas clothes dryer

[1] Includes heat-rated fireplaces or wall heaters

The actual incentive paid per unit will be determined by the Company on a project-by-project basis.

The offer will run from the fall of 2014 through December 31, 2015.

The program budget is \$500,000. All program costs will be accounted for below-the-line, in FERC account 912, in accordance with OAR 860-026-0010.

The Company respectfully requests that the tariff sheets filed herewith be permitted to become effective with service on and after September 15, 2014.
