5. PROMOTIONS

Core Connect 2 Promotion

This promotional offer may not be combined with other discounts unless otherwise specified.

Waive Voice Installation NRC with High Speed Internet

From June 1, 2014 through June 30, 2014, business customers who are contacted by the Company or who contact the Company and request this promotion may be eligible for a discount on the nonrecurring charges that are applicable for installation of a new business line or trunk.

To be eligible, customers must subscribe to High Speed (HSI) Internet concurrent with installation of a new line(s) or trunk(s).
