SOHO Voice Acquisition Offer

During the period October 4, 2014 through April 1, 2015 new business customers who subscribe to Business Unlimited may be eligible for a waiver of the nonrecurring charges otherwise applicable for installation of that service and a credit(s) of the monthly recurring charges.
