Attached for filing are revised and new tariff sheets for Roats' current tariff, PUC Oregon No. 3. As the filing is being submitted with a proposed effective date of January 1, 2017, this filing contains an LSN.

The filing proposes to establish base and commodity rates for domestic service in The Pines and Crown Villa, a monthly rate for irrigation service in The Pines and Crown Villa, and a monthly rate for standard irrigation service outside of The Pines and Crown Villa. It is necessary for Roats to establish these rates in its tariff because Roats is in the process of acquiring a portion of the former Juniper Utility from the City of Bend. The sale will close by December 31, 2016, and Roats will begin serving the new customers on January 1, 2017. As such, Roats requires tariffed rates in place at which it will charge these new customers. Juniper customers who fall into one of Roats' existing rate schedules will be charged at current rates until the rates developed in Roats' current rate case, UW 166, take effect.
