To Whom It May Concern:

Please find enclosed for electronic filing revised tariff pages being filed on behalf of Stayton Cooperative Telephone Company, Inc. (“Stayton”) Access Services Tariff P.U.C. Or. No. 4. The purpose of this filing is to revise intrastate switched access rates for Stayton and concurring carriers as required in the FCC’s November 18, 2011 Report and Order and Further Notice of Proposed Rulemaking in WC Docket Nos. 10-90, etc. (FCC 11-161), and the FCC’s April 25, 2012 Second Order on Reconsideration in WC Docket Nos. 10-90, etc., Order, DA 12-47. This filing affects interexchange carriers that order intrastate access service.

In compliance with the above referenced FCC Orders, this filing revises the following:

- In accordance with FCC 11-161, all intrastate fixed and terminating switched access rates are revised to be at parity with NECA’s interstate switched access rates that become effective July 1, 2017.
- In accordance with FCC 12-47, both originating and terminating Toll VoIP-PSTN rates are revised to be at parity with NECA’s interstate switched access rates that become effective July 1, 2017.

There are currently seventeen companies that concur with the terms and conditions of the Stayton Cooperative Telephone Company, Inc. Tariff P.U.C. Or. No. 4, which are listed in Appendix A. Each company listed in Appendix A has filed their own revised rates and charges for services offered under the tariffs listed in Appendix A.

We are requesting an effective date of July 1, 2017.
