**Re: UE 238 - Steam Sale Agreement between PGE and Boardman Foods, Inc.  
Advice Filing 2016-S5 (Extension Request through 3-31-17)**

Per ORS 757.005, 757.007, and 757.009, enclosed for filing is an Amendment to Steam Sale Agreement between Portland General Electric Company (PGE) and Boardman Foods, Inc. ("Boardman Foods").

PGE filed Advice S-2 on August 12, 2016 requesting an extension of the expiration date of the Steam Sale Agreement to December 31, 2016, and received approval through OPUC Order 16-361 dated September 27, 2016. PGE is requesting an additional extension of the expiration date to March 31, 2017. This extension request is the result of a request from ConAgra Foods Lamb Weston, Inc. ("Con Agra"), one of PGE's other steam customers in Morrow County. ConAgra is currently undergoing a corporate reorganization and has indicated that its contract team will be very busy in the next few months working on the reorganization. As a result, ConAgra has requested that the execution of its new Steam Sale Agreement be delayed and expects to be able to complete negotiation of the Steam Sale Agreement by the end of the first quarter of 2017.

In order to keep the terms of all steam sale agreements aligned, PGE is requesting that the expiration date of the Steam Sale Agreement with Boardman Foods be extended from December 31, 2016 to March 31, 2017.

PGE filed an extension filing for ConAgra (Advice 2016-S3) on October 21, 2016, and plans to file an extension for the Columbia River Processing agreement (Advice 2016-S4) in the near future.



PGE will file all of the new agreements with the OPUC for its review at the close of negotiations, and anticipates that it will request that these agreements become effective on April 1, 2017.

AMENDMENT TO STEAM SALE AGREEMENT

THIS AMENDMENT TO STEAM SALE AGREEMENT (this "Amendment") is made and effective as of this 30 day of Sept. 2016 ("Effective Date"), by and between Portland General Electric Company ("PGE") and Boardman Foods, Inc. ("Boardman Foods"). PGE and Boardman Foods are sometimes referred to in this Amendment in the singular as "Party" and in the plural as the "Parties."

WITNESSETH

WHEREAS, PGE and Boardman Foods have heretofore entered into that certain Steam Sale Agreement effective November 1, 2011 (the "Agreement") pursuant to which PGE agreed to sell steam to Boardman Foods and Boardman Foods agreed to purchase steam from PGE for the purpose of using steam for Boardman Foods' industrial operations.

WHEREAS, pursuant to an Amendment to Steam Sale Agreement effective May 9, 2016, the Parties agreed to extend the expiration date of the Agreement to December 31, 2016.

WHEREAS, PGE and Boardman Foods now wish to extend the expiration date of the Agreement from December 31, 2016 to March 31, 2017, and to enter into negotiations for a new Steam Sale Agreement to become effective April 1, 2017.

NOW, THEREFORE, the Parties hereby agree that the Agreement be amended as follows:

1. All capitalized terms used in this Amendment, to the extent not otherwise expressly defined herein, shall have the same meanings ascribed to such terms in the Agreement
2. As of the Effective Date of this Amendment, the Agreement is hereby amended to extend the expiration date of the Term from December 31, 2016 to March 31, 2017.
3. Except as provided herein, the terms and conditions of the Agreement shall be unmodified and shall continue in full force and effect. To the extent, if any, that the terms and conditions of this Amendment conflict with the terms and conditions of the Agreement, the Agreement is amended accordingly, and the terms and conditions of this Amendment shall control.
4. Each Party represents that it has the full legal right, power and authority to enter into this Amendment and that this Amendment shall constitute a valid and legally binding obligation of such Party enforceable against such Party in accordance with its terms.
5. This Amendment may be executed in one (1) or more counterparts, each of which when taken together shall constitute one and the same Amendment. Counterparts bearing facsimile signatures shall be deemed to constitute originals.

IN WITNESS WHEREOF, the Parties have caused this Agreement to be executed by their duly authorized officers as of the Effective Date.
