Due to a communications oversight, the tariff author was operating under historical filing timelines for CTC of OR as 10 days prior to effective date for small company regulation. PUC staff identified in May of 2015 that CTC of OR should be treated as a large telecommunications utility because of its affiliation with Frontier Communications Northwest Inc. Staff indicated that this should be a 30 day filing, however, due to this being a national product roll-out, the company is asking that this filing be reviewed under less than statutory notice so Oregon speed to market and availability of the product is not affected. The requested effective date is September 23, 2015.
