SUSPENSION EXTENSION AGREEMENT

Pursuant to a previous Suspension Extension Agreement, the tariff suspension deadline in this docket was extended to November 15, 2009. In a Prehearing Conference Report dated October 14, 2009, a revised schedule was adopted by the Commission in this docket that anticipates a Commission decision by March 31, 2010. That Prehearing Conference Report also noted that Portland General Electric ("PGE") had agreed to file with the Commission an agreement to further suspend the tariffs in this docket until April 1, 2010.
