RE: Stayton Cooperative Telephone Company, Inc., Supplemental Filing to Advice Letter 6 – Access

To Whom It May Concern:

Please find enclosed for electronic filing a Supplemental Filing to Advice Letter 6 being made on behalf of Stayton Cooperative Telephone Company, Inc. ("Stayton") Access Services Tariff P.U.C. No. 4 and concurring carriers. In accordance with the FCC's November 18, 2011 Report and Order and Further Notice of Proposed Rulemaking in WC Docket Nos. 10-90, etc. (FCC 11-161), Toll VoIP-PSTN Traffic Originating Local Switching rate and the 800 Data Base Access Service Query rates are being revised to be at parity with NECA's interstate switched access rates that were filed with the FCC on June 16, 2017 to become effective July 1, 2017. This filing affects interexchange carriers that order intrastate access service.

Replacement tariff pages are being filed to make changes to the Toll VoIP-PSTN Traffic Originating Local Switching rate and the 800 Data Base Access Service Query rates for the following companies that were originally filed on May 22, 2017. 
