## RE: Supplemental Filing of Advice No. 15-03, Streetlighting Bill Code Clean Up

Portland General Electric (PGE) submits this supplemental filing pursuant to Oregon Revised Statutes 757.205 and 757.210, and Oregon Administrative Rule (OAR) 860-022-0025, for filing proposed tariff sheets associated with Tariff P.U.C. No. 18. PGE initially filed Advice No. 15-03 on February 13, 2015 with a requested effective date of March 25, 2015, which remains the same. In that original filing, PGE asserted that the cited administrative rules do not apply because this filing does not propose prices.

This revision is submitted at the request of OPUC Staff to provide more information that complies with OAR 860-022-0025. OAR 860-022-0025 requires that PGE submit a statement of the tariff schedule change, the number of customers affected, the change in revenue, and the grounds supporting the change. At the time of PGE's initial filing, we believed that there were no customers with the lights or poles of the service types. PGE is proposing to remove. Upon further review, PGE identified eight customers that were billed under one of the pole options. These eight customers have been moved to an equivalent bill code with the same price, resulting in no change in cost to customers or to annual revenue. No other customers are affected by the proposed changes,

All sheets remain as previously filed.

Pursuant to ORS 757.220, and OAR 860-022-0020, PGE also is submitting an application requesting a waiver of legal statutory notice.
