# 16.1 SERVICE PROVIDER NUMBER PORTABILITY SERVICE 16.1.5 OBLIGATIONS OF THE CUSTOMER (Cont'd)

- G. If an end user of a ported number selects a different local exchange telecommunication service provider, the new provider will be responsible to coordinate the disconnect and new connect orders of the ported number with the Company.
- H. SPNP services cannot be resold or shared.
- I. The AEC will be responsible to order a sufficient quantity of paths per SPNP number, not to exceed the technical limitations of the SPNP option ordered.
- J. The AEC is responsible for all charges for the provisioning of SPNP services.

### **16.1.6** LIMITATIONS OF SERVICE

- A. Transmission characteristics may vary depending on the distance and routing necessary to complete the ported call. An SPNP number is not guaranteed for satisfactory transmission of data.
- B. The number of calls that may be simultaneously routed per SPNP number can not exceed the technical limitations of the SPNP option ordered. Additionally, other technical limitations may apply further reducing the number of simultaneously routed calls.
