DISPOSITION: AMENDMENT APPROVED

On January 9, 2003, Wantel Telecommunications, Inc. and Qwest Corporation filed a tenth amendment to the interconnection agreement previously acknowledged by letter of the Public Utility Commission of Oregon (Commission) issued December 3, 1999, recognizing the adoption of ARB 1 terms, and with subsequent amendments approved by Order Nos. 00-761, 01-441, 01-587, 02-768, 03-028 and 03-100. The parties seek approval of the current amendment under Section 252(e) of the Telecommunications Act of 1996. The Commission provided notice by posting an electronic copy of the agreement and amendment on the World Wide Web, at: http://www.puc.state.or.us/caragmnt/. Only the Commission Staff (Staff) filed comments.

Under the Act, the Commission must approve or reject an agreement reached through voluntary negotiation within 90 days of filing. The Commission may reject an agreement only if it finds that:

- (1) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
- (2) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity.

Staff noted that an interconnection agreement or amendments thereto have no effect or force until approved by a state Commission. *See* 47 U.S.C. Sections 252 (a) and (e). Accordingly, Staff pointed out that the effective date for these filings will be the date the Commission signs an order approving them, and that any provisions stating that the parties' agreements are effective prior to that date are not enforceable.

Staff recommended approval of the amendment. Staff concluded that the amendment to the previously approved agreement does not appear to discriminate against telecommunications carriers who are not parties to the agreement and does not appear to be inconsistent with the public interest, convenience, and necessity.

### **OPINION**

The Commission adopts Staff's recommendation and concludes that there is no basis under the Act to reject the amendment to the previously approved agreement. No participant in the proceeding has requested that the amendment be rejected or has presented any reason for rejection. Accordingly, the amendment should be approved.

#### **CONCLUSIONS**

- 1. There is no basis for finding that the amendment to the previously approved agreement discriminates against any telecommunications carrier not a party to the agreement.
- 2. There is no basis for finding that implementation of the amended agreement is not consistent with the public interest, convenience, and necessity.
- 3. The amendment should be approved.

#### ORDER

IT IS ORDERED that the amendment to the previously acknowledged and approved agreements, between Wantel Telecommunications, Inc. and Qwest Corporation, is approved.
