### DISPOSITION: APPLICATION APPROVED

On June 22, 2004, Portland General Electric Company (PGE) filed an application with the Public Utility Commission of Oregon (Commission), pursuant to ORS 758.430 and OAR 860-025-0015, requesting an order authorizing the transfer of customers and facilities pursuant to a contract between PGE and the City of Canby (City)<sup>1</sup> allocating to the City certain service territory in Clackamas County. These customers and facilities are located on properties that were annexed by the City during the timeframe of April through June of 2003.

The Commission published notice of the application in the Canby Herald, a newspaper of general circulation in Canby, Oregon, on July 17 and 21, 2004. The Commission received no comments or objections from the public.

Based upon Staff's analysis, the transfer avoids any duplication of electric utility facilities between PGE and Canby Utility Board (Canby Utility). Canby Utility is the sole provider of electric services within the City. All parcels annexed by the City are within City limits and are bordered by properties currently served by Canby Utility. The transfer was a cooperative transfer based on the terms of the Territory Allocation Agreement between PGE and Canby Utility approved by Commission Order No. 38537, entered April 4, 1962,

and subsequently amended pursuant to Order No. 98-356, entered August 24, 1998. The basis for the current request is detailed in Staff's recommendation memo, attached as Appendix A.

# ORDER

IT IS ORDERED that the application filed by Portland General Electric Company for authority to transfer customers and facilities to Canby Utility Board is approved.
