DISPOSITION: APPLICATION APPROVED

On March 4, 2005, A & G LLC Water & Sewer (A & G) filed an application with the Public Utility Commission of Oregon (Commission) to waive the \$100 late statement fee (late fee). Pursuant to ORS 756.310, each utility is required to pay the Commission an annual fee. Payment is due on April 1 of each year. If the utility does not pay by 5:00 p.m. on the fifth business day following the due date, a late fee of \$100 is assessed. OAR 860-036-0095(3)(c). Pursuant to OAR 860-036-0001(1), the Commission may relieve any obligations under Division 36 rules. When the current owners acquired A & G in June 2004, they were unaware of the outstanding annual fee balance. Since the current owners paid the outstanding gross revenue fee and incorrectly believed the \$100 late fee would be waived at that time, the application for waiver of the late fee should be approved. A description of the filing is contained in the Staff Report, attached as Appendix A, and incorporated by reference.

At its Public Meeting on March 22, 2005, the Commission adopted Staff's Recommendation and approved A & G's application for waiver of its late fee.

### **ORDER**

IT IS ORDERED that A & G LLC Water & Sewer's application to waive the \$100 late statement fee assessed on its gross revenue fee due April 1, 2004, is granted.

### **STAFF RECOMMENDATION:**

Pursuant to ORS 756.310, OAR 860-036-0001(1), and the then effective OAR 860-036-0095(3)(c), Staff recommends that the application filed by A & G LLC Water & Sewer (A&G or Company) to waive the \$100 late statement fee assessed on its gross revenue fee (annual fee) be approved.

### **DISCUSSION**:

A&G is a public water utility and, as such, is subject to ORS 756.310 that requires each public utility to pay the Commission an annual fee. Annual fee statements are mailed to each public utility every year on March 5. Payment of the annual fee to the Commission is due on April 1 each year. Per OAR 860-036-0095 the fee is considered late if it is not received by 5:00 p.m. on the fifth business day following the due date and is assessed a late fee of \$100 per OAR 860-036-0095(3)(c).

A&G requests that the \$100 late fee be waived. When the current owners acquired the Company in June 2004, they were unaware of the outstanding annual fee balance. Nevertheless, upon receipt of Commission Invoice AR 130101 dated December 9, 2004, the Company paid the total

outstanding fee of \$55.20 plus a penalty of \$9.90 (2 percent per month through December 2004). A&G incorrectly believed the \$100 late statement penalty fee would be waived at that time. The Commission informed the Company that the \$100 late statement fee was still owed. Subsequently, on March 4, 2005, A&G LLC Water & Sewer filed a request for waiver of the fee.

Pursuant to OAR 860-036-0001(1):

... Upon application by a water utility, the Commission may relieve it of any obligations under these rules.

Since the current owners were unaware a gross revenue fee was owed at the time it acquired A&G, and since they paid the outstanding fee and 2 percent penalty following receipt of PUC Invoice AR 130101, Staff recommends that the Commission relieve A&G of its obligation to pay the \$100 late fee pursuant to OAR 860-036-0001(1).

# PROPOSED COMMISSION MOTION:

Pursuant to ORS 756.310, OAR 860-036-0095(3)(c), and OAR 860-036-0001(1) the application of A & G LLC Water & Sewer to waive the \$100 late statement fee assessed on its gross revenue fee due April 1, 2004, be approved.
