DISPOSITION: AMENDMENT APPROVED

On March 27, 2006, Pipertel Communications, LLC, (Pipertel) and Qwest Corporation (Qwest) filed a second amendment to the interconnection agreement and subsequent amendment previously approved by the Public Utility Commission of Oregon (Commission) in Orders No. 05-621 and 05-715. The parties seek approval of the amendment under Section 252(e) of the Telecommunications Act of 1996. The Commission provided notice by posting an electronic copy of the agreement and amendment on the World Wide Web, at: http://www.puc.state.or.us/caragmnt/. Only the Commission Staff (Staff) filed comments.

Under the Act, the Commission must approve or reject an agreement or amendment thereto reached through voluntary negotiation within 90 days of filing. The Commission may reject an agreement only if it finds that:

- (1) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
- (2) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity.

An interconnection agreement or amendment thereto has no effect or force until approved by a state Commission. *See* 47 U.S.C. Sections 252 (a) and (e). Accordingly, the effective date of this filing will be the date the Commission signs an order approving it, and any provision stating that the parties' amendment is effective prior to that date is not enforceable.

Staff recommended approval of the amendment. Staff concluded that the amendment to the previously approved agreement does not appear to discriminate against telecommunications carriers who are not parties to the agreement and does not appear to be inconsistent with the public interest, convenience, and necessity.

OPINION

The Commission concludes that the amendment to the agreement does not appear to discriminate against telecommunications carriers who are not parties to the agreement and does not appear to be inconsistent with the public interest, convenience, and necessity. Accordingly, the amendment should be approved.

CONCLUSIONS

- 1. There is no basis for finding that the amendment to the previously approved agreement discriminates against any telecommunications carrier who is not a party to the agreement.
- 2. There is no basis for finding that implementation of the amended agreement is not consistent with the public interest, convenience, and necessity.
- 3. The amendment should be approved.

ORDER

IT IS ORDERED that the amendment to the previously approved agreement between Pipertel Communications, LLC, and Qwest Corporation is approved.
