#### STAFF RECOMMENDATION:

I recommend the Commission approve Pacific Power & Light's application.

#### **DISCUSSION:**

On November 9, 2006, Pacific Power & Light (PPL or Company) filed this application under OAR 860-027-0300 requesting authorization to defer the costs associated with a Commission-selected Independent Evaluator (IE) retained to evaluate PPL's 2012 Request for Proposals (RFP) for base load resources. In accordance with ORS 757.259(4), PPL requests it be allowed to accrue interest on the unamortized balance at a rate equal to its weighted average cost of capital most recently approved by the Commission.

Previously, the Commission revised competitive bidding guidelines by Order No. 06-446. Guideline No. 5 of the Order addresses the selection and contracting processes for an IE and provides that a utility may request deferred accounting to track the costs of an IE for later inclusion in customer rates. In Order No. 06-550, the Commission selected Boston Pacific and Accion Group as the Oregon IE for PPL's RFP. Order No. 06-676 clarified that PPL should retain the IE even if the Commission did not approve the company's request for RFP approval, and that the company may recover appropriately incurred Oregon IE fees through deferred accounting.

### Reason for Deferral

Adoption of this deferred account is authorized by 757.259(2)(e) in order to minimize the frequency of rate changes or fluctuation of rate levels. PPL has met the requirements of OAR 860-027-0300 in its filing.

## Proposed Accounting

The proposed deferrals would be recorded in Account 182.3, Other Regulatory Assets. Amortization of the balance would be considered in a subsequent proceeding coincident with inclusion in rates.

#### Estimated Deferrals in Authorization Period

PPL anticipates that the IE costs will be approximately \$670,000.

#### PROPOSED COMMISSION MOTION:

PPL's deferred accounting application for IE costs associated with its Draft 2012 RFP and interest accrual be approved effective with the date of the application.
